Application

This is an application for judicial review in respect of the Sucker Creek First Nation #150A.

On December 10, 2024, the Election Appeal Committee of the Sucker Creek First Nation #150A released a decision calling for a new election based on three appeals.

On February 22, 2025, the membership of the Sucker Creek First Nation was advised that Chief and Council had decided not to hold a new election contrary to the decision of the Election Appeal Committee.

The Chief and Council of Sucker Creek First Nation #150A have unilaterally decided not to follow the Customary Election Regulations of the Sucker Creek First Nation by asserting that the decision of our Election Appeal Committee is of no legal force and effect.

The applicant makes an application for:

An order compelling the Chief and Council to hold a new election; Alternatively, an Order clarifying the state of the law and compelling the Chief and Council to adhere to the Customary Election Regulations of the Sucker Creek First Nation #150A.

The grounds for the application are:


The Customary Election Regulations of the Sucker Creek First Nation #150A set out the rules and procedure for election appeals. The Chief and Council are not following these rules and procedures.

Additionally, The Customary Election Regulations include the procedure to change or amend the Regulations. The Respondent has failed to follow these provisions.
