## APPLICATION

**THIS IS AN APPLICATION** to the Federal Court filed in accordance with section 57 of the *Trademarks Act*, RSC 1985, c T-13 (the “**Act**”) and Rule 300(b) of the *Federal Courts Rules* seeking: (1) the expungement of Canadian trademark registration for BIBISHIRINI, bearing Registration No. TMA836869; (2) the expungement of Canadian trademark registration for an Oval & Design, bearing Registration No. TMA825386, both registered in the name of an individual by the name of Fahimeh Dabiran; and (3) the expungement of Canadian trademark registration for BB CAFÉ BAKE BOUTIQUE & Design, bearing Registration No. TMA1161683 registered in the name of 7146591 Canada Limited. Details of the Canadian trademark registrations for BIBISHIRINI, Oval & Design, and BB CAFÉ BAKE BOUTIQUE & Design are set out in **Schedule “A”** attached (together, the “**Infringing Marks**”).

### THE APPLICANT MAKES APPLICATION FOR THE FOLLOWING:

1. A declaration and Order pursuant to sections 18(1)(e) and 57 of the *Trademarks Act*, that Registration Nos. TMA836869, TMA825386 and TMA1161683 are invalid and shall be struck by the Registrar from the Canadian Trademarks Register;
2. A declaration that Fahimeh Dabiran filed the applications for Oval & Design and the BIBISHIRINI registered marks, identified in Schedule “A”, in bad faith;
3. A declaration that 7146591 Canada Limited filed the application for the BB CAFÉ & Design registered mark, identified in Schedule “A”, in bad faith;
4. A declaration and Order enjoining the use of the registered marks identified in Schedule “A” by Fahimeh Dabiran and 7146591 Canada Limited, and any licensee businesses, including but not limited to, 2634314 Ontario Inc.;

5. A permanent injunction against the Fahimeh Dabiran and 7146591 Canada Limited, restraining their current and future use of the Infringing Marks and BB Café trade name in Canada;
6. A declaration and Order that the Applicant, Bibi Confectionery Inc., has rights in the trademark بی بی or BIBI (the “**BIBI Word Mark**”) in Canada by virtue of adoption and use in Iran since at least as early as 1987 in association with: “blanched nuts, dried fruits, fruit jams, fruit-based desserts, roasted nuts, salted nuts, baking spices, biscuits, cakes, candies, chocolate, chocolate-based desserts, coffee beans, cookies, dessert mousse, dessert squares, donuts, honey, ice cream, ice cream desserts, pastries, and tea”;
7. A declaration and Order that the Applicant has the exclusive right to use and obtain a registration for the BIBI Logo (Application No. 2,287,441) as a trademark in Canada in association with the goods and services included with the BIBI Word Mark (collectively, the “**BIBI Marks**”);
8. An interim, interlocutory and permanent injunction to restrain the Respondents, their officers, directors, servants, agents, employees, successors, assigns, licensees and any affiliated company of the Respondents, and all those over whom they exercise control, directly or indirectly:
  - a. Passing-off the Respondent’s goods and services as and for those of the Applicant by displaying, promoting, advertising or otherwise associating the Infringing Marks or any other trademarks confusingly similar to the BIBI Marks, with goods and services provided by the Respondents such that notice of the association is given to the purchaser or potential purchaser;
  - b. Directing public attention to the Respondent’s retail establishments using signage and other indicia of the BIBI Marks and business of the Applicant in Iran in such a manner as to cause, or be likely to cause, confusion in Canada with respect to the source of the goods and services provided by the Respondents; and

- c. Infringing the Applicant's copyright in the BIBI Logo artistic work;
9. An Order declaring that the Respondents have directed public attention to their goods and services and business in such a way as to cause, or be likely to cause, confusion in Canada with the Applicant's goods and services and business, contrary to section 7(b) of the *Trademarks Act*, RSC 1985 T-13, as amended;
  10. An Order declaring that the Applicant is the assignee of all copyright in the BIBI Logo, and that the Copyright Registration No. 1,207,600 in the BIBI Logo is valid;
  11. An Order declaring that copyright in the BIBI Logo has been infringed by the Respondents;
  12. General damages or an accounting of profits for passing-off, in excess of \$100,000, as the Applicant may elect;
  13. General damages or statutory damages for copyright infringement, as the Applicant may elect;
  14. Punitive and/or exemplary damages in the amount of \$500,000;
  15. The costs of this Application on the highest allowable scale or fixed by the Court as a lump sum on a solicitor-and-client scale; and
  16. Such further relief as this Honourable Court deems just.

**THE GROUNDS FOR THIS APPLICATION ARE:**

17. The Applicant, Bibi Confectionery Inc. ("**Bibi Confectionery**" or "**Applicant**"), is a Canadian corporation that was incorporated on September 25, 2023, having a principal place of business at Unit 719 - 20 Scrivener Square, Toronto, Ontario.
18. Bibi Confectionery was incorporated in Canada to operate as a branch of the original business first established as a bakery business in 1987 in Tehran, Iran, under the

trademark **بی بی** in Farsi / Bibi and business name **بی شیرینی بی**, anglicized and herein after referred to as “**Shirini Bibi**”, which translates to English as Bibi Pastry or Bibi confectionery.

19. As a family business, owned and run by six brothers, Shirini Bibi is one of the most famous pastry shops in Iran with three locations and a 40,000 sq ft factory. It is known for its signature chocolate cake, as well as an assortment of other Iranian pastries, baked goods, chocolate, ice cream, nuts and dried fruits. Shirini Bibi prides itself on the quality of its products and the tradition that they carry.
20. Shirini Bibi has registered its intellectual property in Iran as of 1987, including trademark registration of the word **بی بی** (Bibi in Farsi) in association with International Class 30.
21. As well, Shirini Bibi uses several variations of its instantly recognizable BIBI Logo that has become synonymous with Shirini Bibi’s business, appearing on storefronts and on the packaging for the goods:

22. With the permission and license of Shirini Bibi, the Applicant filed for a trademark application in Canada of the composite “Bibi Logo”, depicted above right, on October 18, 2023, under Application No. 2287441 (the “**BIBI Logo**”). Copies of the Canadian Intellectual Property Office page for the BIBI Logo are attached as **Schedule “B”**.
23. Copies of the Iranian trademark registrations and photographs depicting the use of the BIBI name and marks used in Tehran since 1987 are attached as **Schedule “C”**.

24. The BIBI Logo also represents a unique and original artistic work created by one of the owners of Shirini Bibi in Tehran, which has been the predominant trademark and symbol of the business of Shirini Bibi since at least as early as 1987 and printed on all products and packages, as shown in the attach **Schedule “D”**.
25. The centerpiece of the BIBI Logo is a stylized representation of “Shirini Bibi” in Farsi. It is not a font that is available anywhere for writing in Farsi but a unique stylization that was created by one of the owners of Shirini Bibi. The author of the artistic work and co-owner of Shirini Bibi, registered copyright in the BIBI Logo in Canada on October 25, 2023, claiming a date of first publication as July 23, 1987, under Registration No. 1,207,600. The author also assigned all copyright in the BIBI Logo to Bibi Confectionery in Canada. A copy of the Canadian copyright registration and assignment is attached as **Schedule “E”**.
26. Having established a significant reputation locally in Iran, Shirini Bibi has also accumulated a significant international following over the years. The BIBI Logo is a nostalgic hallmark of Iranian culture for expatriates and former residents of Iran and its associated goods have become a popular gift for visitors to and from Tehran.
27. This widespread success and fame of the bakery in Tehran, coupled with the large Iranian and Persian community in Toronto, has led to Shirini Bibi’s ability to export its products abroad, including to Canada, through local Iranian retailers as early as 2005. In doing so, Shirini Bibi has made use in Canada of its BIBI Marks through local retailers in association with the sale of its authentic baked goods.
28. Due to the success and ongoing demand for its products in Canada, Shirini Bibi has been taking active steps expand its business with the view of opening physical locations in Canada, including incorporating its subsidiary and the Applicant herein, Bibi Confectionery Inc., on September 25, 2023.

29. As a result of extensive use since 1987 in Iran and since 2005 in Canada, a significant number of Persian-Canadians are familiar with Shirini Bibi's business in both Iran and Canada and recognize the BIBI Marks as identifying Shirini Bibi as the source.
30. As such, Shirini Bibi recently took steps to protect its trademark rights in Canada in the name of Bibi Confectionery, in order to open a Toronto location to serve the significant Persian community established in the Greater Toronto Area ("**GTA**").
31. In or around 2022, Shirini Bibi became aware of confusion among Iranian Canadians caused by a bakery in Toronto, Ontario operating under variations of the trade name "BB Café", "BB Café & Restaurant" and "BB Patisserie" in English, and بی شیرینی بی بی and بی بی in Farsi ("BB Café") and holding itself out as a Canadian branch of Shirini Bibi. To the Applicant's knowledge, the first location opened at 6095 Yonge Street in the Toronto Iranian Plaza in or about 2010. The Iranian Plaza is also known as Little Tehran.
32. The Respondent, 7146591 Canada Limited ("**591**"), with a registered business address at 6095 Yonge Street, North York, Ontario, appears to be operating the BB Café business in Canada and is the owner of for the BB CAFÉ BAKE BOUTIQUE & Design trademark application.
33. The Respondent, Fahimeh Dabiran ("**Dabiran**" together with 519, the "**Respondents**"), is an individual residing in Richmond Hill, Ontario. On July 2, 2010, Dabiran personally applied to register the BIBISHIRINI and Oval & Design trademarks, in association with a variety of baked goods, including pastries and cakes, and services related to the sale of baked goods as well as serving tea and selling juices and nuts.
34. Dabiran is identified as the chief officer and director of 591, along with an individual who is identified as sharing the same residential address, Saeed Khakbaz Nejad.
35. The business of BB Café appears to be run by, 2634314 Ontario Inc. ("**314**") using several variations of the trade name "BB Café & Restaurant" and "BB Patisserie", including using the word بی بی (Bibi) and بی شیرینی بی بی , (Shirini Bibi) in Farsi. Mr. Nejad is a director of 314.

36. As well, the Respondents have been using a logo, registered by Ms. Dabiran as “Oval & Design”, that incorporates the distinct elements of the BIBI Logo as depicted below:

35. Examples of use of the BIBI Marks by Shirini Bibi in comparison to BB Café are attached as **Exhibit “F”**.
36. Further, Ms. Dabiran has a history of filing trademark applications for variations on these trademarks, including abandoned Canadian applications for B.B. PATISSERIE, Application No. 1467791, and B.B. CAFÉ, Application No. 1467762, which were both abandoned in March of 2011.
37. Dabiran has also filed to register the word mark BB’S BAKERY, Application No. 2160079, which is currently opposed by the Applicant.
38. Dabiran has also filed to register the word mark “Cakes.bybb”, Application No. 2204268 which remains pending.
39. 591 has also filed an application in Canada to register the trademark BB CAFE, Application No. 2312689, which remains pending.
40. A complete list of all trademark filings made by the Respondents in Canada, including abandoned applications, is attached hereto as **Schedule “G”**.

41. To the Applicant's knowledge, the Respondent does not use the trademark BIBISHIRINI. It is important to note that *shirini* means "pastry" and *Shirini Bibi* translates from Farsi to English to mean "Bibi Pastry".
42. The phrase BIBISHIRINI is an awkward inversion of the way the words would normally be spoken in Farsi. In Farsi, letters are read from right to left, but if you read our logo from left to right (as in English), the order would be BIBI SHIRINI which is not grammatically correct in Farsi. Further, the English words "BB Café" would not translate into Farsi as "Shirini or Ghanadi Bibi", but "Café Bibi" or "Coffee Shop Bibi". Therefore, the BIBISHIRINI trademark applied for by Dabiran is not an accurate or true translation for BB Café's English business name.
43. Dabiran deliberately filed several trademark applications in her personal name so that these would be concealed from anyone searching for Shirini Bibi or Bibi as a name. Further, she registered the artistic "Shirini Bibi" as under the name "Oval & Design" and registered the reversed and compounded version of "Shirini Bibi", i.e. Bibishirini, again making these trademarks very difficult to find and preventing the Applicant from asserting and enforcing its exclusive rights.
44. The conduct of Dabiran and 591 in applying for a large number of variations of marks containing the predominant elements of the Shirini Bibi name and BIBI Marks reflects bad faith efforts to register every possible iteration and class associated with Bibi's business in Canada and is in the names of entities that are not clearly identified as operating the business of Dabiran.
45. The Respondents use the Oval & Design Logo, "Shirini Bibi" and "Bibi" in Farsi on storefronts, signage, on packaging, and in association with bakery products (e.g., cardboard under cakes, plastic cover around cakes).
46. Further, the Respondents attend major Iranian events and have booths where they continue to use the Oval & Design Logo and "Shirini Bibi" in Farsi on their banners and

signage, misleading Iranian customers by creating a false association with the famous Shirini Bibi in Iran.

47. The Respondents not only adopted identical elements as the BIBI Marks and BIBI Logo at issue, but early news and interviews reporting on the business shows the Respondents claiming to be importing goods from Shirini Bibi in Iran and that the business in Canada was a “tribute to the original Shirini Bibi”. These claims were clearly made in a bad faith attempt to lend legitimacy to the theft of intellectual property that the Respondents did not own.
48. The adoption and use of the distinct BIBI Marks and BIBI Logo, created and made famous by the owners of Shirini Bibi in Tehran since at least as early as 1987, predates the trademark applications filed by the Respondents in Canada by more than two decades.
49. In light of BB Café’s public comments and marketing strategies, it is clear that the Respondents are fully aware of the Shirini Bibi business in Tehran, Iran, and have deliberately adopted the identical name and trademarks with a business in Canada, in an effort to trade on the considerable goodwill and reputation of Shirini Bibi in Tehran.
50. In fact, due to the use of the BIBI Marks and the Respondent’s imitation of Shirini Bibi’s goods consumers have been misled into believing that BB Café is a branch or affiliate or licensee of Shirini Bibi in Canada.
51. When filing the trademark applications in dispute, Dabiran knew that she was not the person entitled to register the trademarks BIBISHIRINI and Oval & Design, because these famous marks belonged to Shirini Bibi in Iran, that she was very familiar with.
52. The Respondents acted in bad faith in filing the trademark applications at issue in these proceedings. In doing so, the Respondents acted with willful and reckless disregard for the rights of the Applicant and its owners, the original creators of Shirini Bibi in Tehran.

53. Further, the Respondents have substituted their goods for those Shirini Bibi, applying the BIBI Marks to products of inferior quality.
54. In the early years of BB Café's business and unbeknownst to Shirini Bibi, the Respondents imported goods bearing the BIBI Marks from Shirini Bibi in Iran to sell to Canadian consumers at BB Café locations. Later, BB Café sold its own substituted products in association with the BIBI Marks and other false labels such as "Shirini Bibi Tehran at Shirini Bibi Toronto", without the consent or license of the Applicant.
55. The Respondents' use of the BIBI Marks in association with near identical goods in Canada constitutes a false representation to ultimate consumers that the baked goods derive from the same source as the Applicant's. These misrepresentations are calculated to injure the business of the Applicant and goodwill of Shirini Bibi in its BIBI Logo in Canada.
56. The conduct of the Respondent is calculated to deceive the public into believing that the Respondent and its goods and services are affiliated with the Shirini Bibi and such depreciation or confusion is a reasonably foreseeable consequence of the conduct referred to herein.
57. The use of the packaging and marketing materials that deceive consumers into believing that BB Café is an affiliate or distributor of the Applicant's products in Canada constitutes an attempt to pass-off the Respondents' products as and for those of Shirini Bibi in a manner that is contrary to section 7(c) of the *Trademarks Act*.
58. The use by the Respondents of the label "Shirini Bibi Tehran in Shirini Bibi Toronto" and BIBI Marks in association with its own goods and services is deliberately done in a manner so as to associate their products with the Applicant, such that notice of the association is given to the person whom the goods are transferred and/or the services are rendered.
59. In an earlier interview, Fahimeh Dabiran claims that Iranians all over the world know Bibi Bakery in Iran and its famous cakes. BB Café has also copied the signature Bibi cake design,

advertising it as “taste of nostalgia”, “our classic cakes”, “our famous cake”, “same taste as Tehran”. All of these statements are false and misleading.

60. Bibi Confectionery sent a demand letter to the attention of Dabiran on or about December 22, 2023, outlining the bad faith nature of the trademark filings and registrations at issue in these proceedings and complaining of other false and misleading claims made by the Respondents.
61. Counsel for the Respondents replied to the demand letter in or about February of 2024, indicating that they would not cease use of the trademarks or comply with any of the Applicant’s demands, because of the Applicant’s lack of registered rights in Canada.
62. Furthermore, the Respondents doubled down on their claim to the Shirini Bibi marks by filing for yet another “BB Café” trademark application on February 28, 2024, two months after receiving the demand letter from the Applicant.
63. At the time that Bibi Confectionery sent the demand letter in December 2023, the Respondents had no prior use of the BB Cafe and Cake boutique logo registered as TMA1161683, on at any store signage or products. However, since the demand letter, the Respondents started using the new logo which includes Bibi in Farsi and English, along with the BIBI Marks, to transition customers to the new logo while continuing to trade on the goodwill and reputation attaching to the BIBI Marks and BIBI Logo in Canada.
64. By reason of the forgoing activities of the Respondents’ set out herein, the Respondents have infringed and are deemed to infringe the BIBI Marks contrary to sections 19 and 20 of the *Trademarks Act*.
65. The Respondents’ use of the Infringing Marks is deliberately deceptive and has deceived Persian-Canadian consumers in Canada who have purchased products from the Respondents.

66. An independent survey shows that a significant number of relevant consumers mistakenly believe that the Respondent's business is affiliated with Shirini Bibi, because of the use of the Infringing Marks, as well as the overall branding strategy the Respondents' have employed that deliberately trades on the BIBI Marks and BIBI Logo.
67. The Respondents' registrations and applications for the Infringing Marks in Canada, as well as other similar marks, is designed to prevent the Applicant from using its rightful business name and BIBI Marks and BIBI Logo in Canada.
68. The Respondents have acted in bad faith in filing these Infringing Marks in Canada, being fully familiar with the prior adoption and use of the BIBI Marks by the Applicant, given the fame and notoriety of the Iranian bakery that significantly predates the trademark filings of the Respondent in Canada.
69. It is evident that in applying for and using the Infringing Marks, the Respondent is seeking to profit off the reputation of the BIBI Marks and BIBI Logo that enjoy international recognition and are unique and distinctive of the Applicant.
70. Bad faith filing includes the deliberate adoption of a trademark for use in Canada which trades upon another party's well-known name and mark. It also includes the deliberate adoption of a trademark from a foreign entity for use in Canada to trade on the foreign owner's goodwill or sell it to them.
71. The bad faith nature of the Respondents' filings is compounded by their history of similar infringing applications. Dabiran has previously filed a trademark application in Canada for NADERI, bearing Application No. 1,377,385, for a wide variety of food products and the retail sale and distribution of such goods, which application was abandoned.
72. This earlier application for NADERI represents another attempt to register a famous mark and business name used in Iran and evidences a pattern of bad faith conduct. Dabiran abandoned the registration for NADERI by September 2009 and shortly after began filing applications for the Infringing Marks, as shown in **Schedule "H"**.

73. The real owners of Naderi filed a NADERI trademark in Canada on February 17, 2011 under Application No. 1516158 and claiming use in Canada “since at least as early as June 15, 2000”.
74. The Respondents will not cease use of the Infringing Marks, applied for and registered in bad faith, unless the marks are expunged and further use is enjoined by this Honourable Court. The Respondents have already refused to cease use of the BIBI Marks including new “BB” filings in Canada.
75. The deliberate, malicious and callous conduct exhibited in the Respondent’s bad faith actions justify an award of punitive or exemplary damages to deter such action in future.

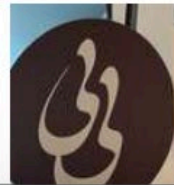
