Statement of Claim

TO THE DEFENDANT

WITHIN 30 DAYS after the day on which this statement of claim is served on you, if you are served in Canada or the United States; or

WITHIN 60 DAYS after the day on which this statement of claim is served on you, if you are served outside Canada and the United States.

TEN ADDITIONAL DAYS are provided for the filing and service of the statement of defence if you or a solicitor acting for you serves and files a notice of intention to respond in Form 204.1 prescribed by the [Federal Courts Rules](#).

Copies of the [Federal Courts Rules](#), information concerning the local offices of the Court and other necessary information may be obtained on request to the Administrator of this Court at Ottawa (telephone 613-992-4238) or at any local office.

IF YOU FAIL TO DEFEND THIS PROCEEDING, judgment may be given against you in your absence and without further notice to you.

i seek relief; performance and compensation

I require an order saying that i Am not to be identified as David Paluch or DAVID PALUCH or DAVID AHAYAH, and it be written clearly upon the face of the order that my officially recognized name is and can only be known as; minister David Solomon of Ahayah

i require an order to remove Stephen J Tanner stand down from his post.

i require Karl Efrenoff compensate: \$100,000 for torture and unlawful detention harming my faith and beliefs

i require Doug Downey destroy/delete/remove DAVID PALUCH from all databases within his power

I require Michelle to have actual criminal cause to call "police" services and also serve thirty days in jail and return Korin my white cat of which i Am the only one with vested interest in him.

Total monetary compensation sits at One Hundred Thousand Dollars (\$100,000)

- 1. i Am a living man by the Name of minister David Solomon of Ahayah**
- 2. i Am a ministering evangelist, officiating all over the land of "Canada"**
- 3. The Bible says God is no respecter of persons and has revealed that persons are corporations**
- 4. A corporation is identified with an all caps name**
- 5. There is an artificial person in which Michelle Lynn Garceau keeps fooling people into thinking i Am, she constantly calls policy enforcement for frivolous and vexatious reasons saying to them i am the person DAVID PALUCH**
- 6. Michelle hates me and wishes i was dead**

- 7. We have children together and she has maliciously done harm to them and i, and has interfered with our God given natural rights to be near one another because she lies to policy men**
- 8. Michelle lost a case in small claims court which is now in assessment in the Burlington CourtHouse SC 23 955, wherein i sued her for the night she falsified a court document with Ben Wolman saying i harmed her.**
- 9. That is a lie and i have proof and evidence she lied under oath**
- 10. A recording exists and pictures were taken to document the bodily harm**
- 11. Everytime i serve her paperwork for court she calls policy men**
- 12. She wastes public resources**
- 13. On the 22nd of January, i entered into the Milton CourtHouse to take a gift to all the staff there which was a carafe of McDonalds coffee**
- 14. I was told by the man and front guard dressed like a police officer that the NAME had a warrant and they needed me to help its CHARGE get WITHDRAWN**
- 15. i said ok, because i wanted to help them, but not contract any further with them**
- 16. i was told we would go into a courtroom and they would do their slave business quickly and i could leave**
- 17. They use tricks and lies to get a man or woman to agree in some form with them; or an agent for them, to form a contract**
- 18. They decided to take me downstairs to the cages again, and took away my stuff, but they were being noticeably strange and acting funny like they were trying to appease me and trick me into the cages to process my flesh again**

19. The entire security staff, blue shirts and black shirts were all involved
20. They promised me i would be let go of that day
21. A man called "Long-something" began processing my belongings and taking pictures of my items and national cards and there were other men in there also
22. i perceived that they were lying
23. i was even told i could keep a string in my pants which is normally removed incase a hostage is suicidal which i think was a move of trickery to make me feel comfortable
24. The Holy Spirit kept indicating something was wrong this whole time, as soon as i walked in i felt the spirits of deception
25. The strange and overly accommodating treatment began to diminish as soon as i was put in a cage
26. They promised they just wanted to keep me safe, but that was a lie because i was tortured later on
27. They placed me into a cage after this processing
28. They made me stretch my arms behind me and i started becoming more duressed by this moment
29. A man name muhammad was there whom took me to division 2 in a car that was a black sports car without policy enforcement markings
30. i waited in another cages after being forced to get naked for a man and i felt molested
31. Soon after that my prints were taken under duress again

32. After that, they started getting meaner

33. i was not afforded any comfort; it was cold and the surface to sleep on is very cold concrete

34. Being forced to lay on concrete caused bruising and pain to both sides of my hip bones and my ribcage and i feel pain as i write this

35. They refused to give me clean water, i cannot drink chlorine which is in the tap water and they didn't care that it makes me sick, by this time i have been fasting for; four days and needed water

36. Karl Efrenoff came and he seemed friendly, he had an australian accent

37. We chatted about my email i sent in a special room

38. When i made it clear that i sent that email to Michelle he indicated he may not be released

39. I told him he has discretion and he had no reason to think i would harm her

40. He said it wasn't his choice

41. He was lying, he was arresting officer, and i have been let go from other policy agents and contractors for this same CHARGE by halton policy men before, named Jake and David from the division at constable henshaw boulevard

42. He tried to tell me it was the staff sergeants choice and refused to give me his name

43. I was put back in the cage and i noticed they robbed me of my fingerprints prior to reading or informing me as to why its being CHARGED

44. i believe this is against their own protocol and the acted out of turn

45. i had to try to sleep with the light on a full power which deprived me of sleep

46. The next morning i was let go after a "bail" hearing
47. The man acting as prosecutor is James Coppolino
48. The man in the black robe started intimidating me about more cages if i seek to be around my children and they mis-identified them as GARCEAU which is not the names they had when born, furthermore i was kept away from Noah Ahayah being born and to this day have not met him because of Sarah Cleghorn, Ben Wolman and Michelle conspiring to convert them in to artificial persons for financial gain using color of law and breaking their own laws and codes in the act
49. I do not understand anything about their system and i do not care to, i wish to be left alone completely
50. All contracts with these people have always been by duress formed under threat of bodily harm and this day is no different
51. They wrongfully arrested me; again applying the artificial person DAVID PALUCH suretyship against i the man, the living soul and flesh
52. It was again because Michelle called this service corporation which acts under color of law, meaning they are pretending to be de jure law enforcement, she did this in response to a loving email
53. I think the Milton Judiciary is corrupt and mad that i challenged in Federal Court because of them for doing wrong; save a woman in a green sash Commisso and maybe Nick Chiera. Commisso should be recognized for her fairness in determining i Am not the person DAVID PALUCH January 3rd courtroom 9 Milton.
54. These policy officers and other like them have never, in all the years i required an oath from them; produce the valid oath
55. That makes them de facto in nature and the Bible says to stay away from this activity
56. The Bible also says not to obey anything that would break God's Law

57. The name is DAVID PALUCH is contained in some sort of data base somewhere under Doug's control and have been torturing me with for over ten years also including the condition of intimidation for my release to have to be babysat by some one from John Howard Society
58. I have reached out to for a long time to Doug Downey, Stephen J Tanner to inform them that i Am not and never will be interested in these contracts
59. The name in point 57 are under care and control of all these men and women who are harming i and my posterity
60. There is no law in the Bible or for Canada that states one is required to be a legal person or have a legal name
61. There is no code rule or regulation that states a man is required to be a person
62. There is no involuntary service on this land
63. I refuse to be a slave
64. These people are starting to make my life feel threatened and i require urgent help
65. i fear they will attack me because i am exercising my rights under God's law to travel
66. I have affixed a plate to a ministry chariot and do not use drivers licenses
67. I believe Canada's supreme court made drivers licenses optional
68. Driver is a commercial title for commercial use
69. Driving is a commercial function

70. A man or woman has the unalienable right to move from point A to Point B as long as they harm no one or cause injury
